V. DEL PUERTO CANYON RESERVOIR UPDATE

Chris White from the San Joaquin River Exchange Contactors Water Authority (SJRECWA) and Adam Scheuber from the Del Puerto Water District (DPWD) gave a presentation on the Del Puerto Canyon Reservoir project. These two partnering agencies are proposing to construct and operate the Del Puerto Canyon Reservoir which features an 800-acre reservoir with a 260foot dam and three saddle dams that would be filled from the Delta-Mendota Canal. Some of the project benefits include improving water supply to farmers and wildlife refuges, capturing Del Puerto Creek runoff to increase flood protection, supporting the local and regional economy, and enhancing local management of groundwater and surface water to benefit local communities. They also discussed addressing community concerns, project funding, the design process and other challenges, including the relocation of major utilities.
