V. COVID-19 RESPONSE UPDATE

Richard Murdock, Assistant Director of Emergency Services provided a brief COVID-19 overview. The County is quickly progressing through Phase 2 of re-opening. COVID-19 cases are anticipated to increase in the fall. The contact tracing project is currently staffed by approximately 90 wokers and operates 7 days a week. County testing sites are located in Salida, Keyes and Patterson. Efforts are being made to work with EMTs to become mobile detectors for the hard to reach areas that include farm laborers and the homeless. Preparation for finalizing Stage 3 of re-opening is underway. Stanislaus County had 45 new positive cases over the weekend, rising to 744 cases total and 1 new death, increasing the total to 29. Agricultural Commissioner Milton O'Haire stated that his office received a large supply of disposable masks for ag-related industry use and is currently distributing them.
